### ASSUMPTION OF RISKS

I am aware that my participation in this recreational activity held October 30, 2019 involves risks and dangers including but not limited to use of and/or exposure to sporting and/or recreational equipment, natural or "person" made, environmental and/or physical conditions, negligence of others, and/or negligence on the part of the **Unifor** and/or its Local Unions, their officers or agents and representatives. I freely accept and fully assume all such risks and dangers and the possibility of personal injury, death, property damage and loss resulting therefrom.

- 1. I AGREE TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future against the **Unifor** National Union and/or **Unifor** Local Unions and/or a **Unifor** Council, and their directors, officers, employees, agents and representatives, (all of whom are hereinafter collectively referred to as "**THE RELEASEES**") and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my use of or my presence at the **Unifor** Union and/or Local Union and/or Council recreational event due to any cause whatsoever, **INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, ON THE PART OF THE RELEASEES;**
- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for damage to property of, or personal injury to, any third party resulting from my participation at the **Unifor** and/or Local Union and/or Council recreational event;
3. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;

In entering into this agreement I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this agreement.

I have read and understand this agreement. I am aware that by signing this agreement I am waiving certain legal rights, which I or my heirs, successors, executors or administrators etc. may have against the Releasees.
